## **Head Start Recognizes Sen. Bob Casey, Rep. Brian Fitzpatrick, and Rep. Glenn Thompson as Congressional Champions for Children and Families**

### **Pledge and PROMISE Awards presented during Head Start Hill Event**

WASHINGTON, D.C. – The National Head Start Association recognized Sen. Bob Casey and Rep. Brian Fitzpatrick (PA-01) with the 2023 Head Start Pledge Award for keeping the commitment to fulfilling the Head Start pledge and serving America’s most vulnerable children and families. NHSA also awarded Rep. Glenn Thompson (R-PA-15) the PROMISE (Protecting Our Most Important Students Early) Award for his continued support of Head Start.

"Pennsylvania has a long history of bipartisan support of Head Start by our elected leaders. Senator Casey and Representatives Fitzpatrick and Thompson are excellent examples of this support," said Blair Hyatt, executive director of the Pennsylvania Head Start Association. "Sen. Casey is an outstanding supporter of early learning and all programs that support children and their families. Pennsylvania benefits from his leadership everyday. Rep. Thompson recognizes the importance of Head Start as a foundation for economic development in Pennsylvania by promoting family self-sufficiency and preparing children for success in school and in life. And Rep. Fitzpatrick is nationally recognized for his successful bipartisan work. His leadership will be essential as we work to address the many challenges facing Head families and programs in the 118th Congress."

Reps. Fitzpatrick and Thompson will receive their awards during the annual Head Start Breakfast on the Hill, where congressional champions have an opportunity to address Head Start parents, alumni, and other supporters who traveled to Washington, D.C. to advocate for the early childhood development program with members of Congress and their staff. NHSA will present Senator Casey with his award when he meets with Head Start advocates.

"The Head Start community is grateful for Sen. Casey, Rep. Fitzpatrick, and Rep. Thompson’s ongoing work to ensure America’s underserved children receive the high-quality education and care they need for a bright future," said NHSA’s Executive Director Yasmina Vinci. "We are
